### MARKET UPDATE – INJUNCTION EXTENDED

Conquest Mining Ltd (ASX: CQT) has been advised by the Company's Managing Director, John Terpu that an injunction over the sale of 15,209,000 shares by the ANZ Bank has been further extended to 2pm (EST) Wednesday 16 April 2008. These shares were subject to an equity finance contract with Opes Prime.
